The meeting was called to order at 7:02 pm at the Winchester Town Hall and via Zoom. Town Board Liaison Report: There is continuing work on the Community Forest Registration process; 4 parcels of land have been put forward. Vilas County zoning hearing concerning Chuck Kramer's proposed building project on county K near the North Lakeland School will be held 9am Thursday February 1, 2024 at the Courthouse in Eagle River. The Town needs to give opinions, and Joe Discianno has been working on preparations. There was a light pollution concern; Town Board may revisit the ordinance.

Commission Member reports: Jim Logan has contacted local politicians concerning Rules pertaining to wake boats, setbacks, lake size restrictions. State Senator Mary Felzkowski has been communicating with Jim on this issue.

Old Business

Dick Logan has been working with the county, and they would like to have town input and work in concert with the town. - 4. Discussion/possible action on lawyer's response to Wake boat ordinance. Ordinance revised 12/5/2023. DNR and lawyer's responses forwarded to Sulo. There will be a public hearing February 10, 2024 at 10am.

- 5. Discussion/ possible action on reviewing maps in Town of Winchester Comprehensive Plan 2021 and Vilas County zoning maps. Tabled until next meeting when all maps have arrived; may be redone online.
